1. Welcome, Call to Order, Sponsor Recognition

4. Finance Report

The most recent financial reports from APA were not available and will be reviewed at the next Executive Committee meeting.

5. Presentation of County Planning Awards

There were 10 outstanding applications submitted that resulted in 6 awards. Brown thanked the awards committee for its hard work. He described the selection process and categories. Each award winner was summarized and presented with the recognition trophy. All the award winners will be highlighted in the upcoming newsletters, and on the Division website.

Award of Merit for Best Practices: McHenry County Illinois' Green Infrastructure Plan which incorporated a detailed inventory of natural resources using the latest technology and information, created a green infrastructure map, identified additional green infrastructure opportunities, and developed policies and implementation recommendations.

Award of Merit for a Planning Project: Sarasota County Florida's Nathan Benderson Park, which transformed a former Interstate Highway shell excavation area into a large mixed use development. The 600 acre regional park includes a world class rowing venue in an Aquatic and Nature Center.

Award of Merit for Grass Roots Initiative: Richland County South Carolina's 8th Annual Neighborhood Planning Conference which brings neighborhood leaders together with professional planners, local administrators and industry professionals to address the struggling nature of urban communities and rural neighborhoods through their Neighborhood Improvement Program.

Award of Excellence for Best Practices: Hillsborough County Florida's City-County Planning Commission for their Guide to Creating and Updating Community Plans in Unincorporated Hillsborough County. The Guide provides consistency to the community plan format and content, and provides guidance to ensure that plans are developed in a manner consistent with the County's overarching planning framework.

Award of Excellence for Small Area/Special Planning: Howard County Maryland's Downtown Columbia Plan, a 30-year master plan for evolving Columbia's suburban-oriented Town Center into a socially, economically and environmentally sustainable urban community. The result is a vibrant city center where people live, work, shop and play within an enriched natural setting that is connected and pedestrian friendly.

Award of Excellence for Special Focus Planning Initiative - Senior Living: Clark County Washington's Aging Readiness Plan. The Plan explores five main elements, identifies challenges and provides 91 strategies. The Aging Readiness Plan is a comprehensive analysis of the challenges and needs identified by the local community, service providers and academic experts through a collaborative approach that created a document that was an accurate and informative assessment of the community and its capacity to support the County's "silver tsunami".

Executive Committee members were introduced. Upcoming vacancies for Chair-Elect, Secretary, Newsletter Editor, Social Media Coordinator and Web Master were again noted.

Chair Brown indicated that outgoing Chair Judy Francis has been provided a plaque in recognition of, and thanks for her years of service to the County Planning Division and NACP.
